Minimum Specifications

Runway Closure Marker, Portable, with Generator and Trailer

These specifications are intended to cover all requirements for the purchase. It is the owner's intent to purchase two (2) identical Runway Closure Markers with the specified components that are ready for use upon delivery. Bid shall be given as **one lump sum**. Taxes and/or shipping and handling charges are to be included in the bid. All equipment furnished shall be new without repair and meet all equipment requirements by State and Federal safety regulations.

NOTE:

A copy of the bidder's specifications for the Runway Closure Markers shall be submitted with the bid. Any manufacturer's name, trade name, brand name, or model number used in these specifications are for the purpose of describing and establishing general quality levels. Such references are not intended to be restrictive. Bidders proposals shall meet or exceed all requirements of the listed specifications.

1. Description

- a. Compliances: FAA A/C 150/5345-55A and NTSB Safety Rec. A-03-05.
- b. FAA Certified – Must provide copy of certification.
- c. Lighted X formed when opened and operating will be at least 14' 0" each continuous leg.
- d. Lighted X form must be fitted with LED bulbs with continuous lights set up.
- e. Flash Interval: Bright Mode – Approximately 2.5 seconds on and 2.5 seconds off and Dim Mode – Approximately 2.5 seconds on and 2.5 seconds off.
- f. The RCM must be able to withstand winds of minimum 40 MPH while in operation mode.
- g. Designed to be visible from at least six miles out in Visual Flight Rules (VFR) conditions at night and three to five miles in VFR daytime.
- h. Power Capacity of minimum 140 hours without refueling.
- i. Run Time: Must be able to run a minimum of 35 hours.
- j. Must have rear hitch, allowing tandem towing of 2 units
- k. Unit arms must be powder coated with Aviation Yellow per FED-STD-595.
- l. RCM must have a trailer for transportation and towing.

MANUALS:

Successful bidder shall supply one (1) copy of complete sets of parts, shop repair, and operator's manuals. Electronic versions are acceptable

DELIVERY:

Delivery F.O.B. to 6700 McKennon Boulevard, Fort Smith, Arkansas. **Please list an approximate delivery date in the bid.** Date of delivery shall be considered during the bid award.

WARRANTY:

The purchase shall have a warranty of not less than 1 year. If manufacturer's standard warranty period exceeds 1 years, then the manufacturer's standard warranty period shall be in effect. The warranty shall begin on the date the unit is determined to meet specifications and is accepted into

the Airport's fleet of equipment, not production date. Please submit a detailed statement of the warranty offered with this bid.

OPTIONAL WARRANTY:

Additional costs of extended or optional warranty shall be listed separately from the bid.

REFERENCES:

A minimum of three (3) references of airports or companies who have purchased the equipment specified from your company within the previous 5 years.
